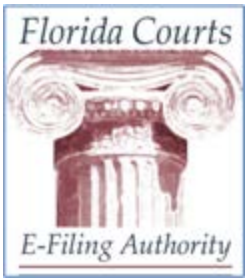

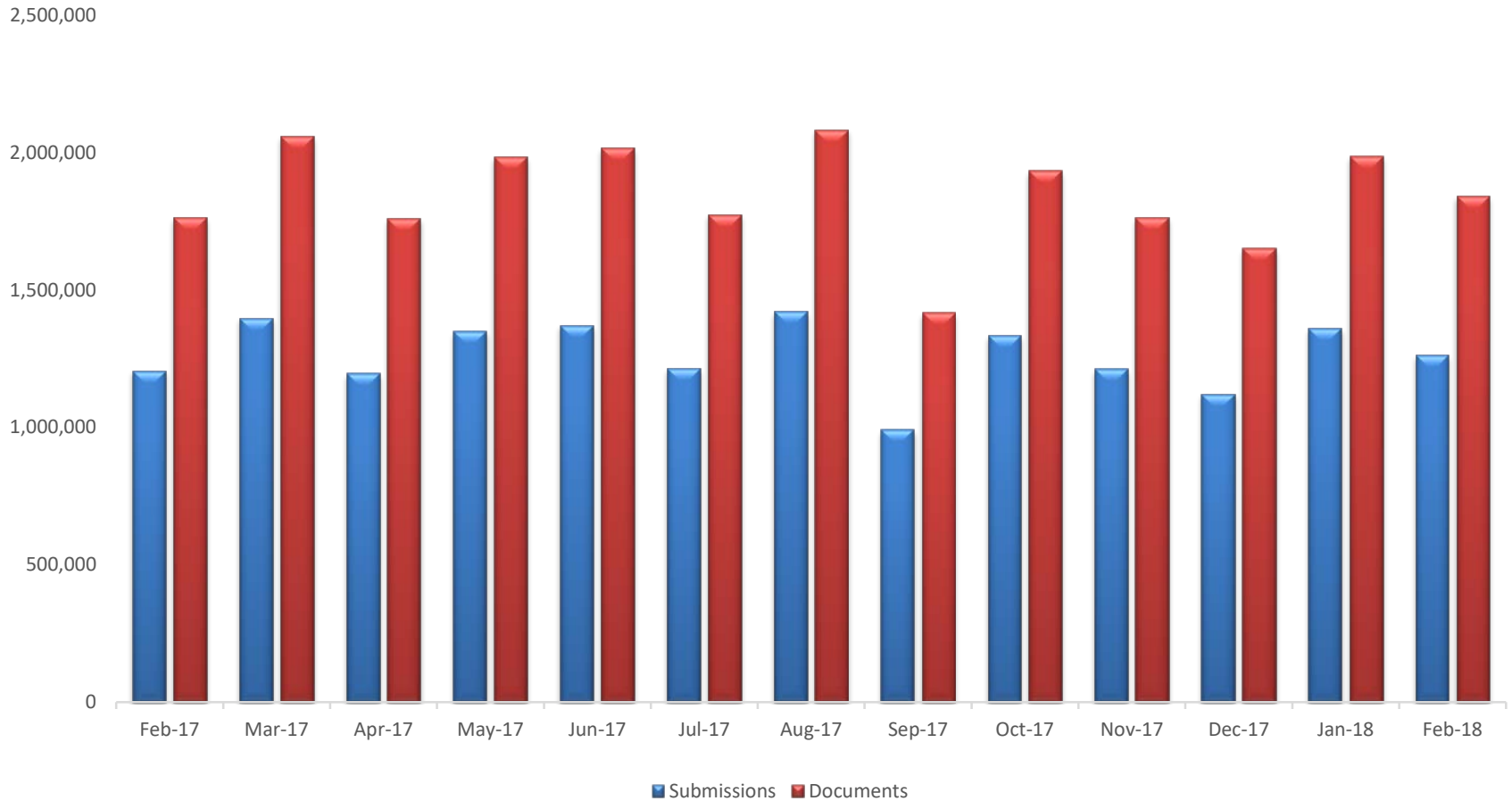
May had the highest volume day on May 31, 2017 at 74,102 submissions

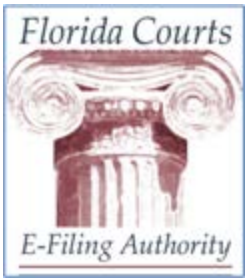
January, 2018 has the most submissions during the 3:00 P.M. hour at 8,531

January, 2018 has the most new cases filed during a given month at 74,629

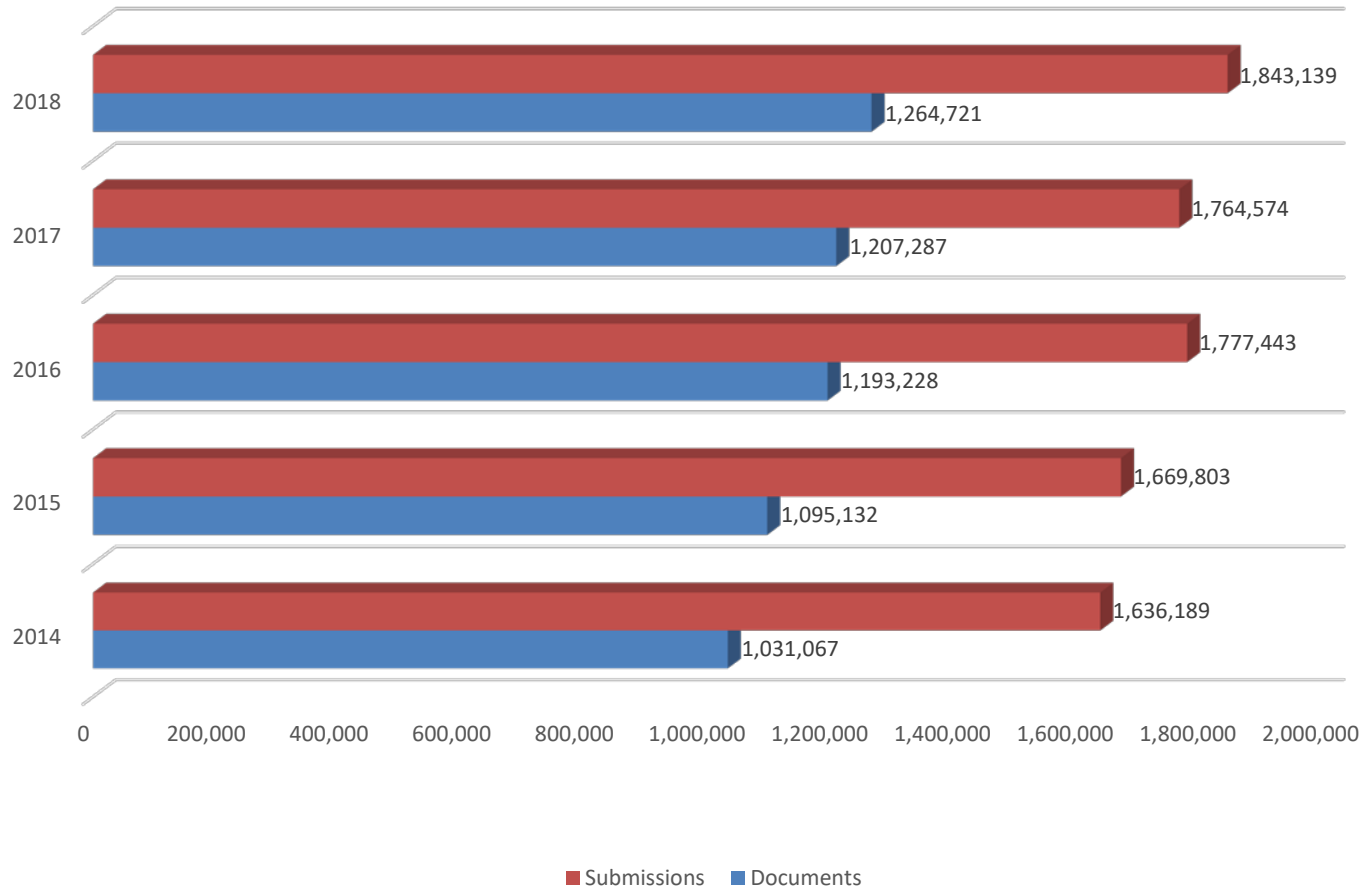


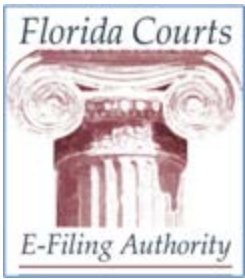
Year at a Glance



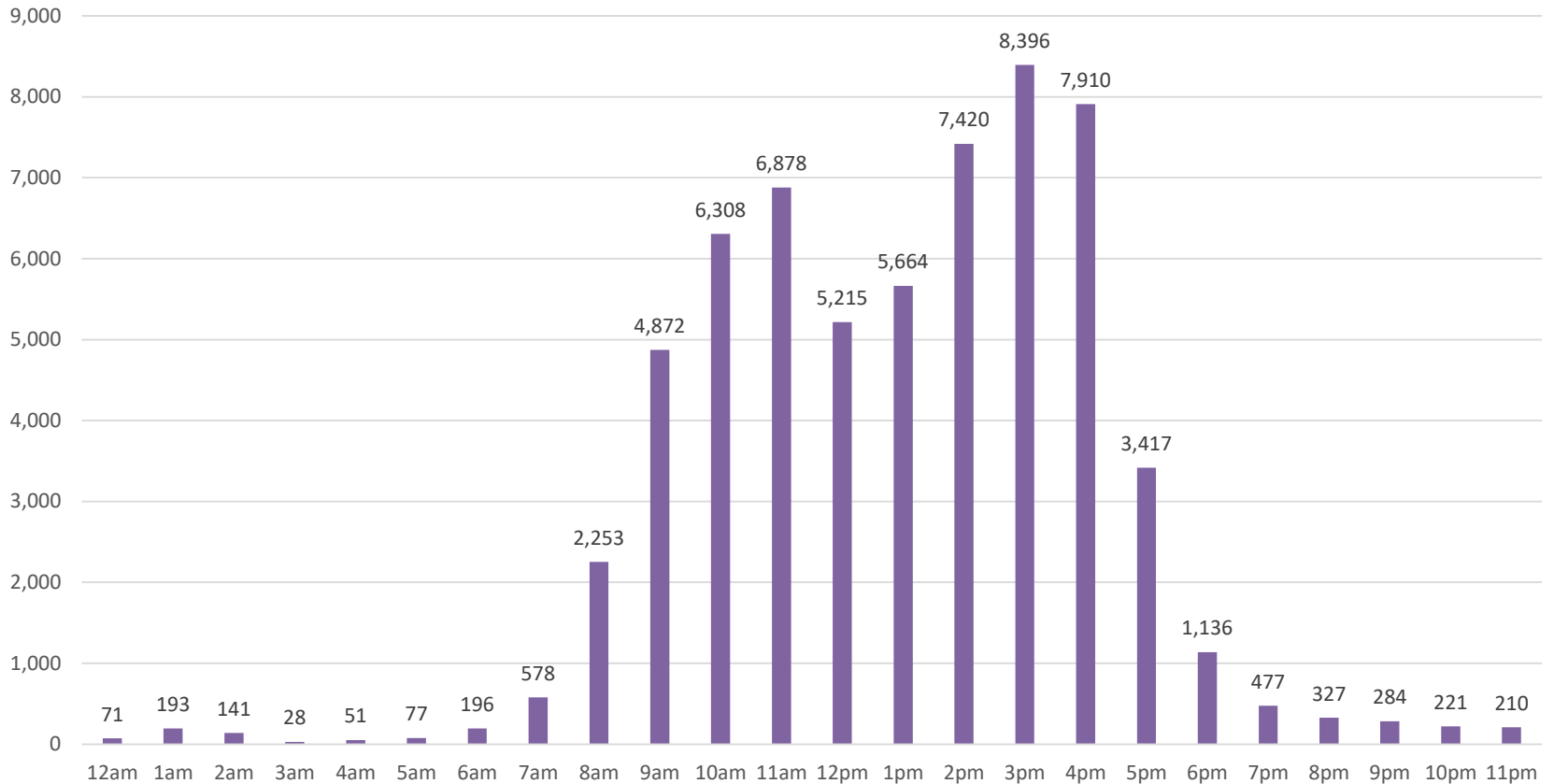


Feb. E-Filing Last Five Years



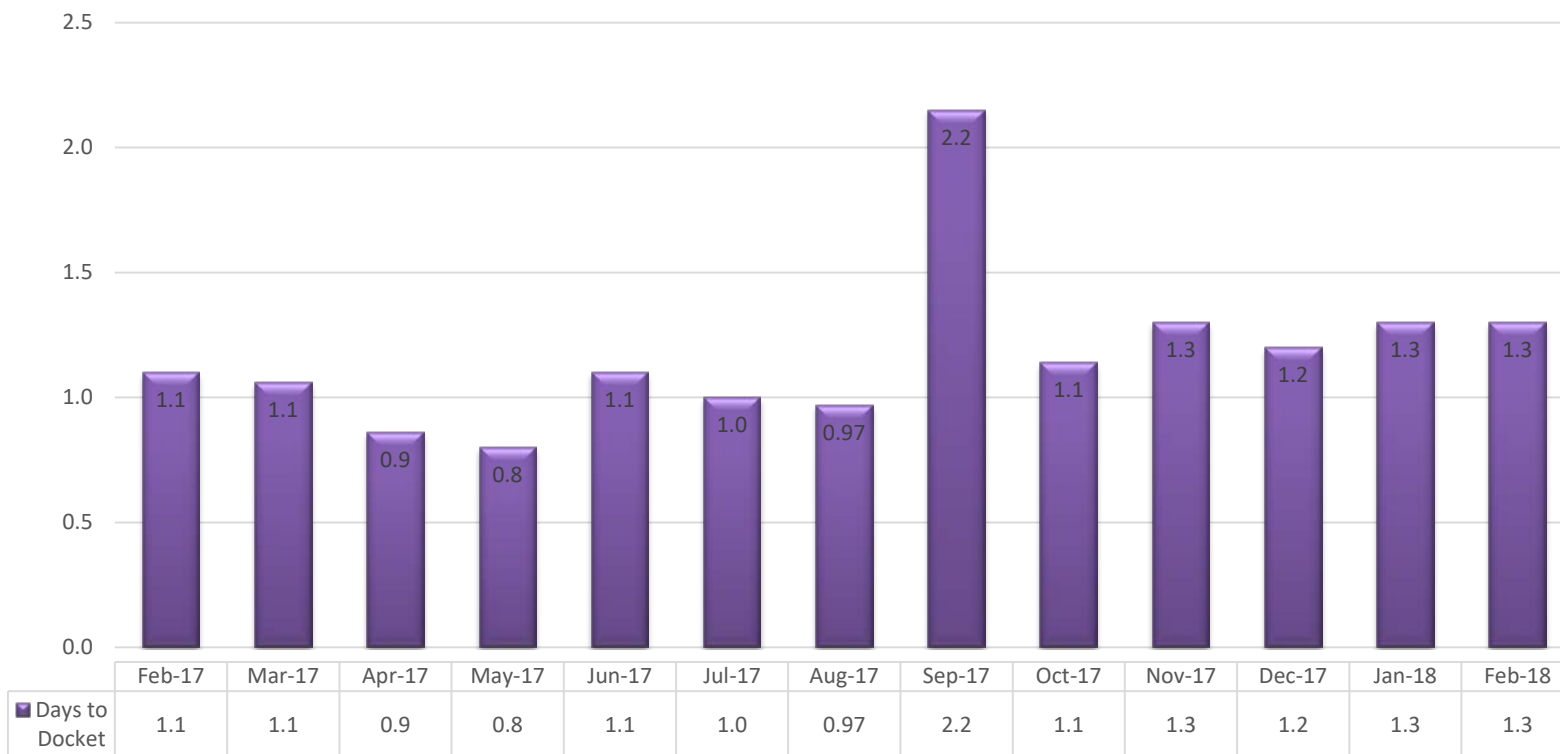


Average # Filings Per Hour in Feb.



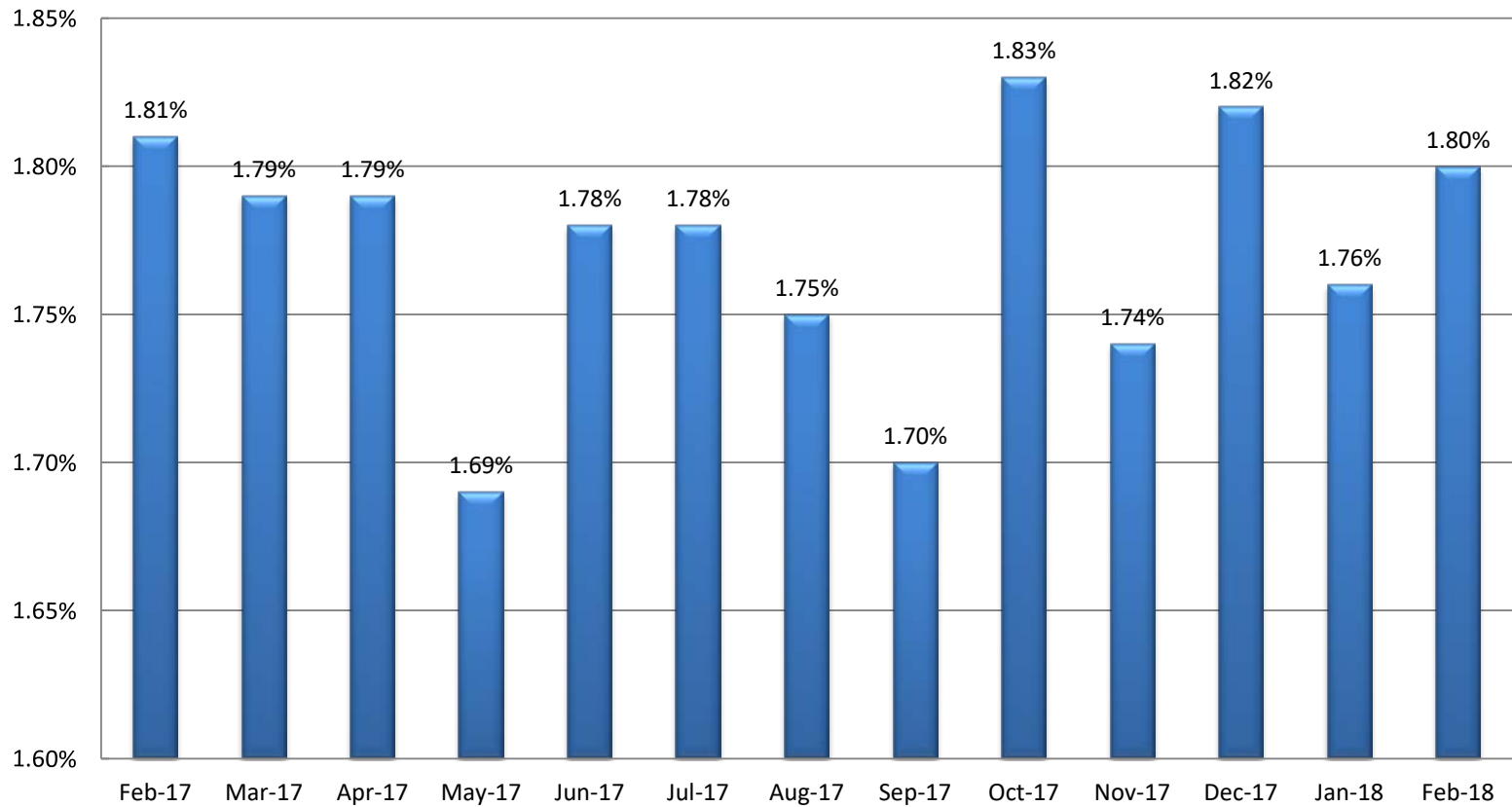


Average # Days to Docket

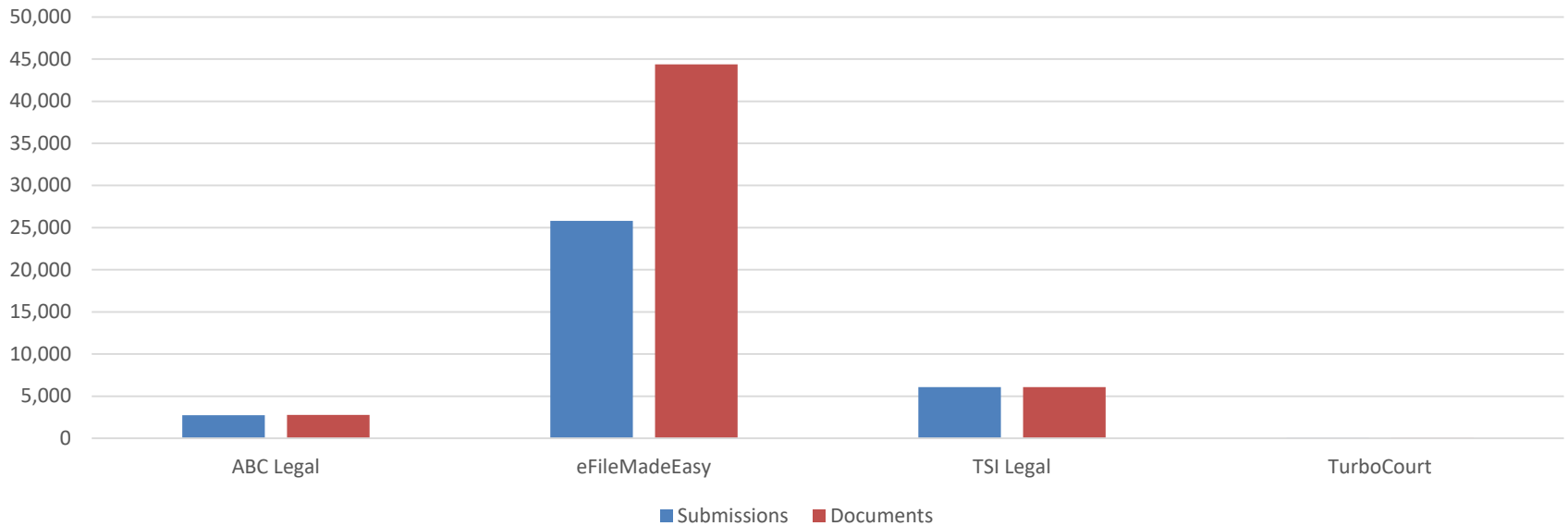

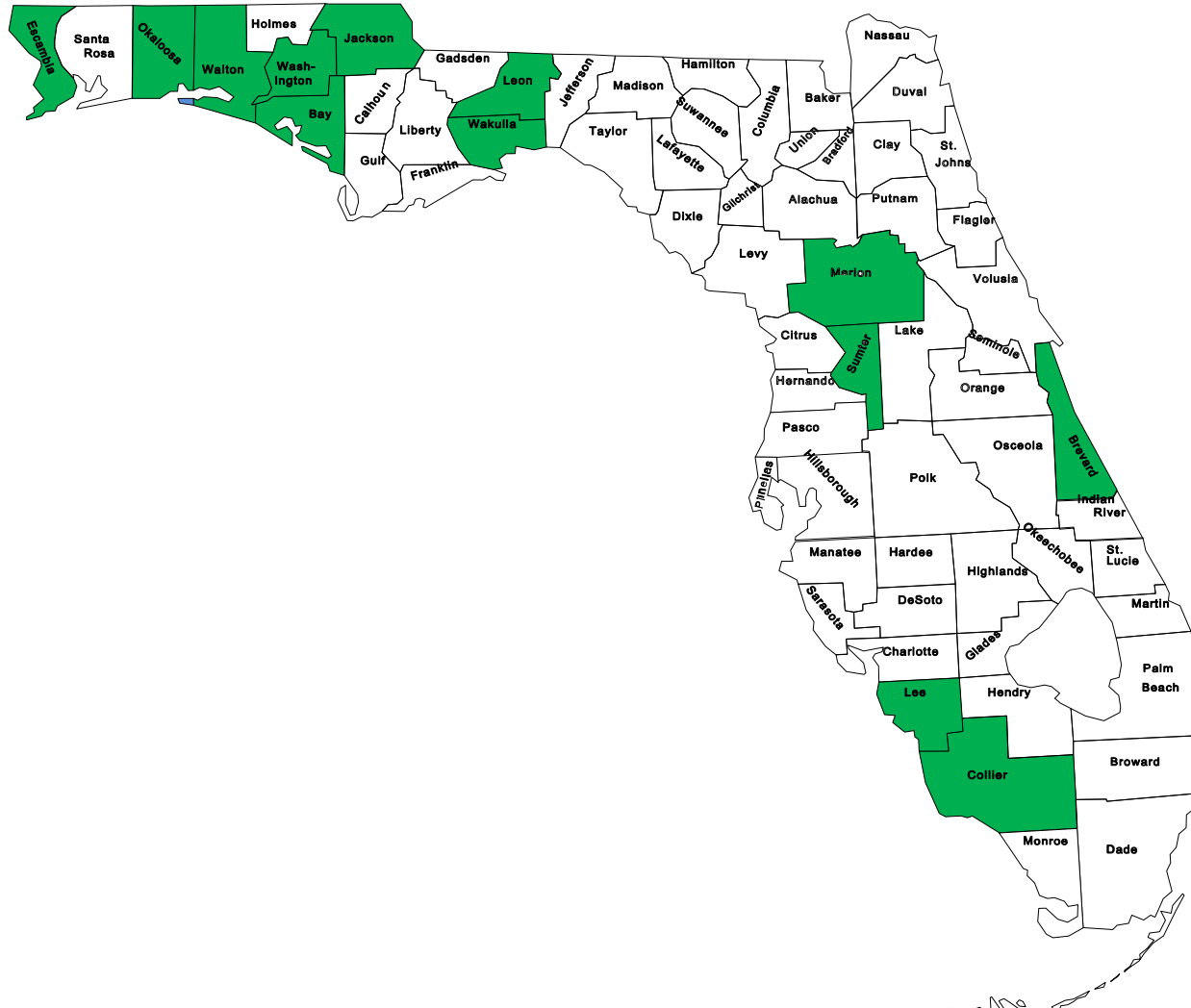

Criminal Case Initiation	Working with FCTC Portal Sub-Committee to scope out the process and prepare a draft document
Release 2018.01	Spec writing for Release 2018.01 – April 20, 2018
Bounce Backs	There are a large number of Portal accounts that receive multiple bounce back notifications. Working to clean up bad email addresses in the Portal
Change Advisory Board	Meets every other month to discuss Portal enhancement requests and make recommendations to the EFAB. Next meeting April 10
