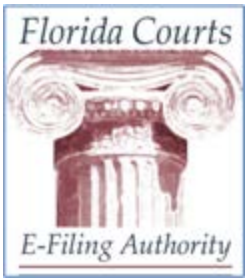

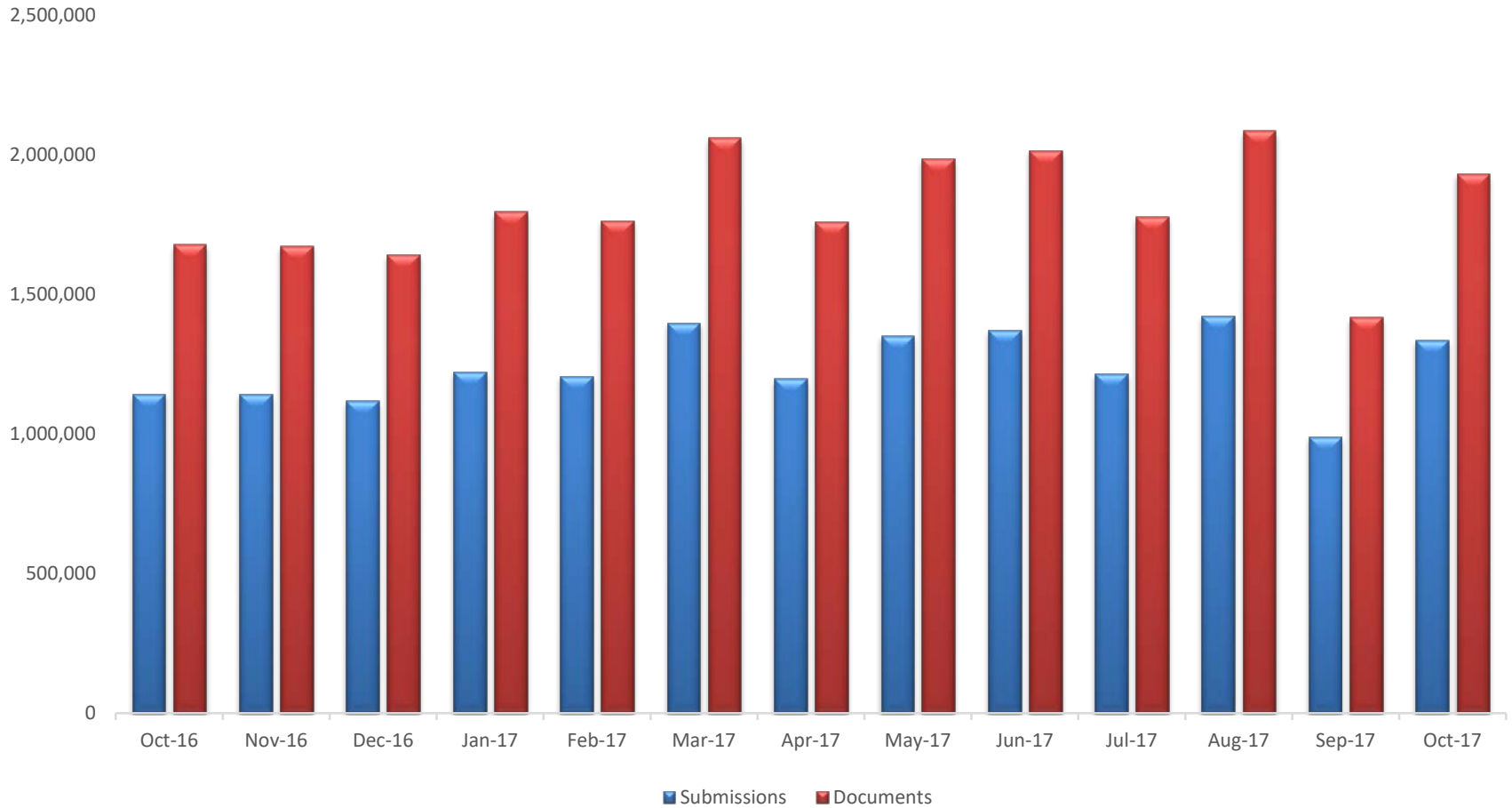
May had the highest volume day on May 31 at 74,102 submissions

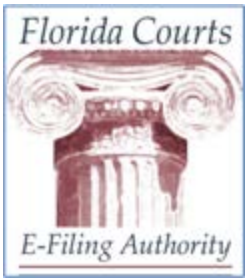
June had the most submissions during the 3:00 P.M. hour at 8,246

August had the most new cases filed during a given month at 72,800

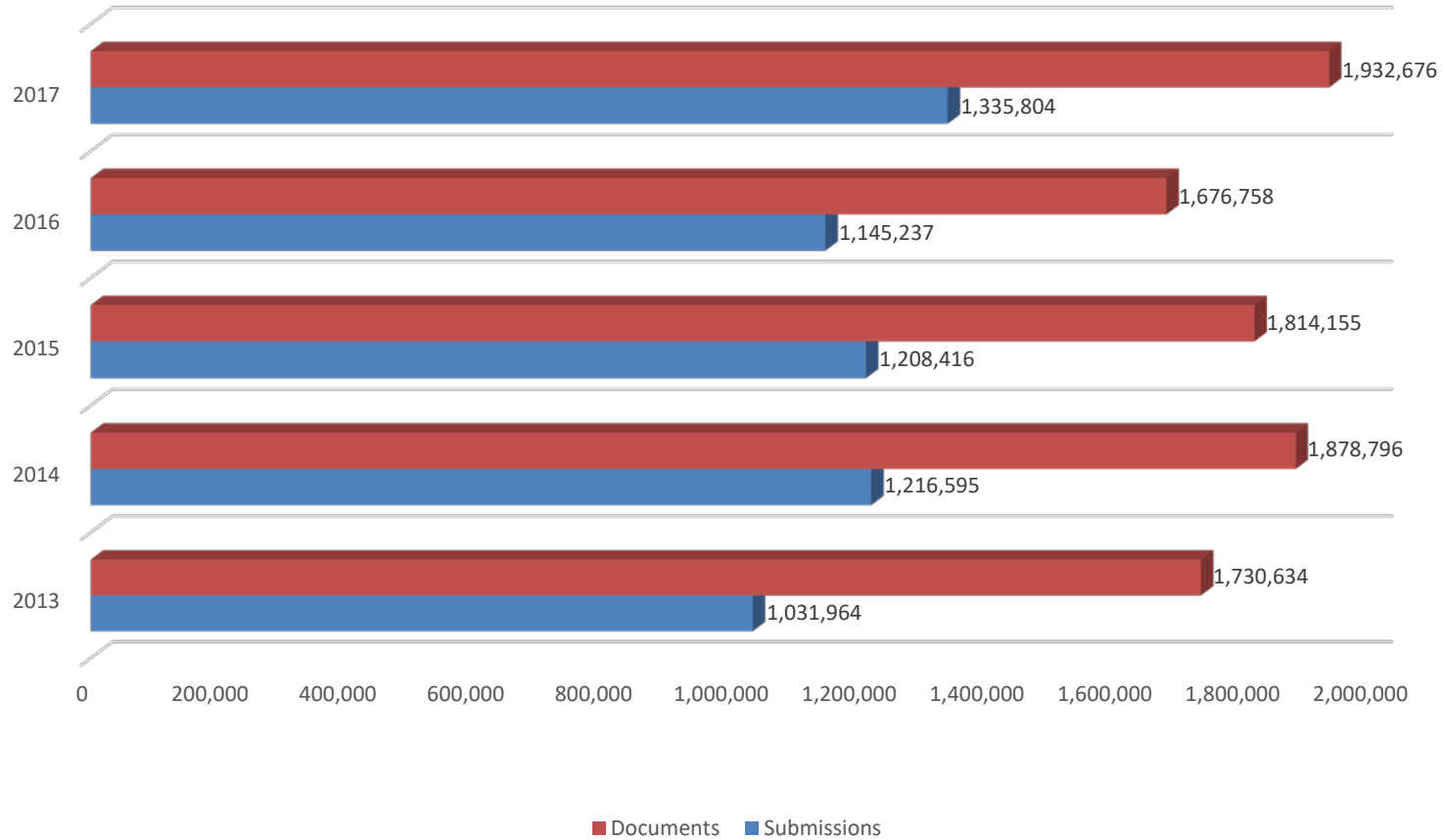


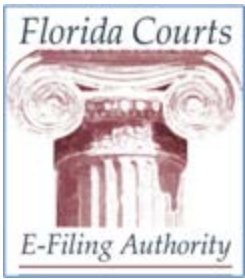
Year at a Glance



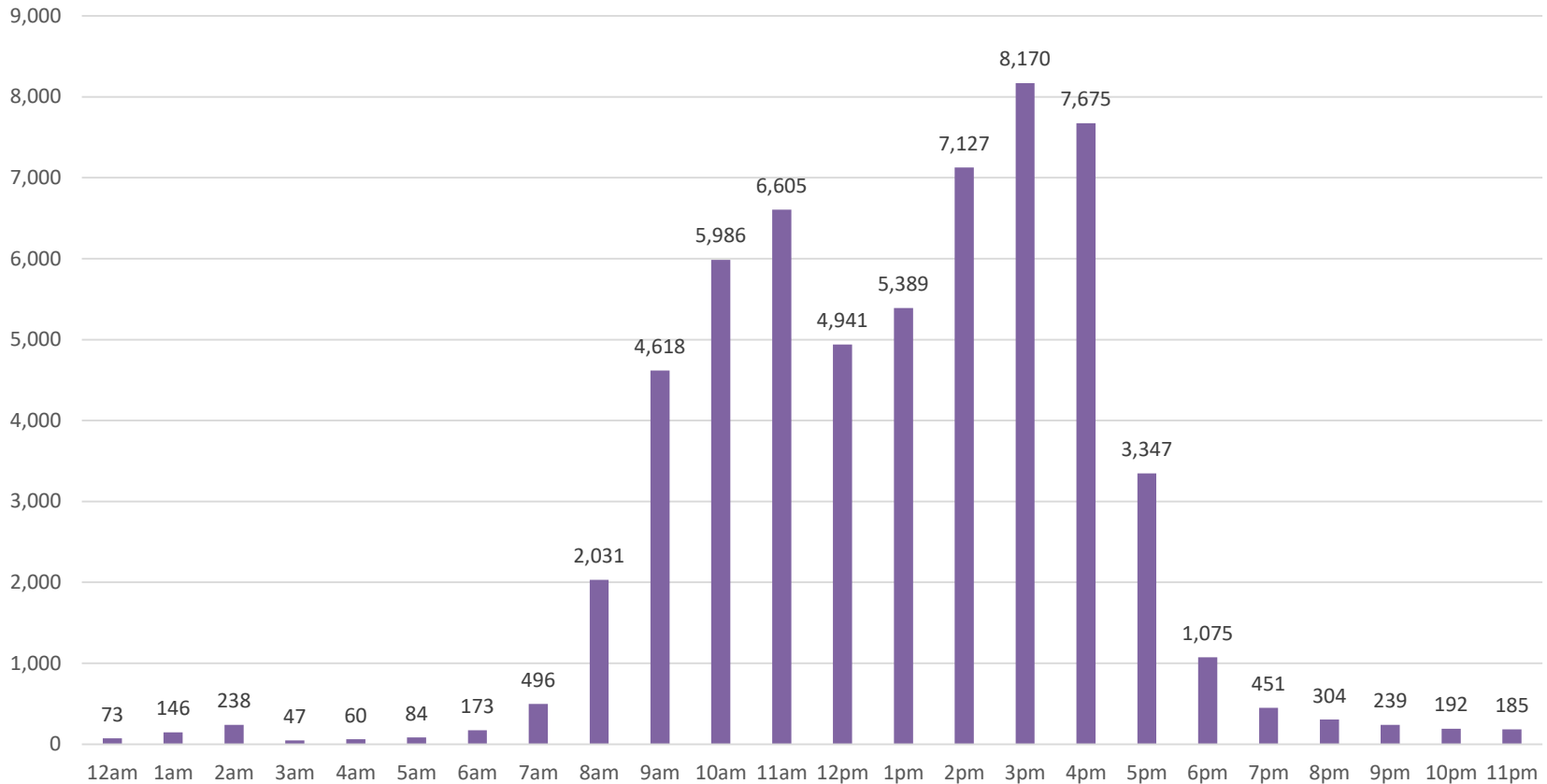


Oct. E-Filing Past 5 Years



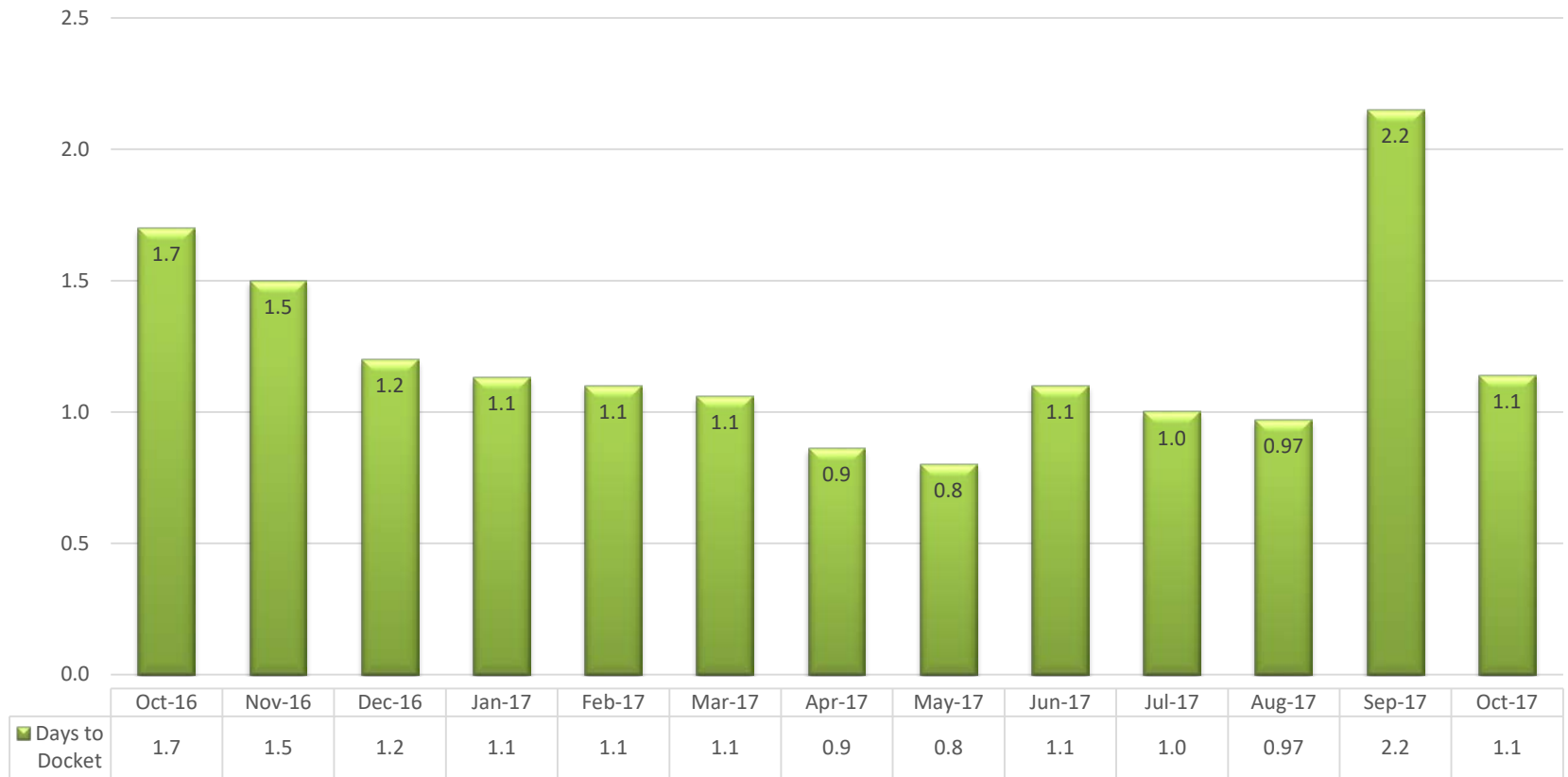


Average # Filings Per Hour



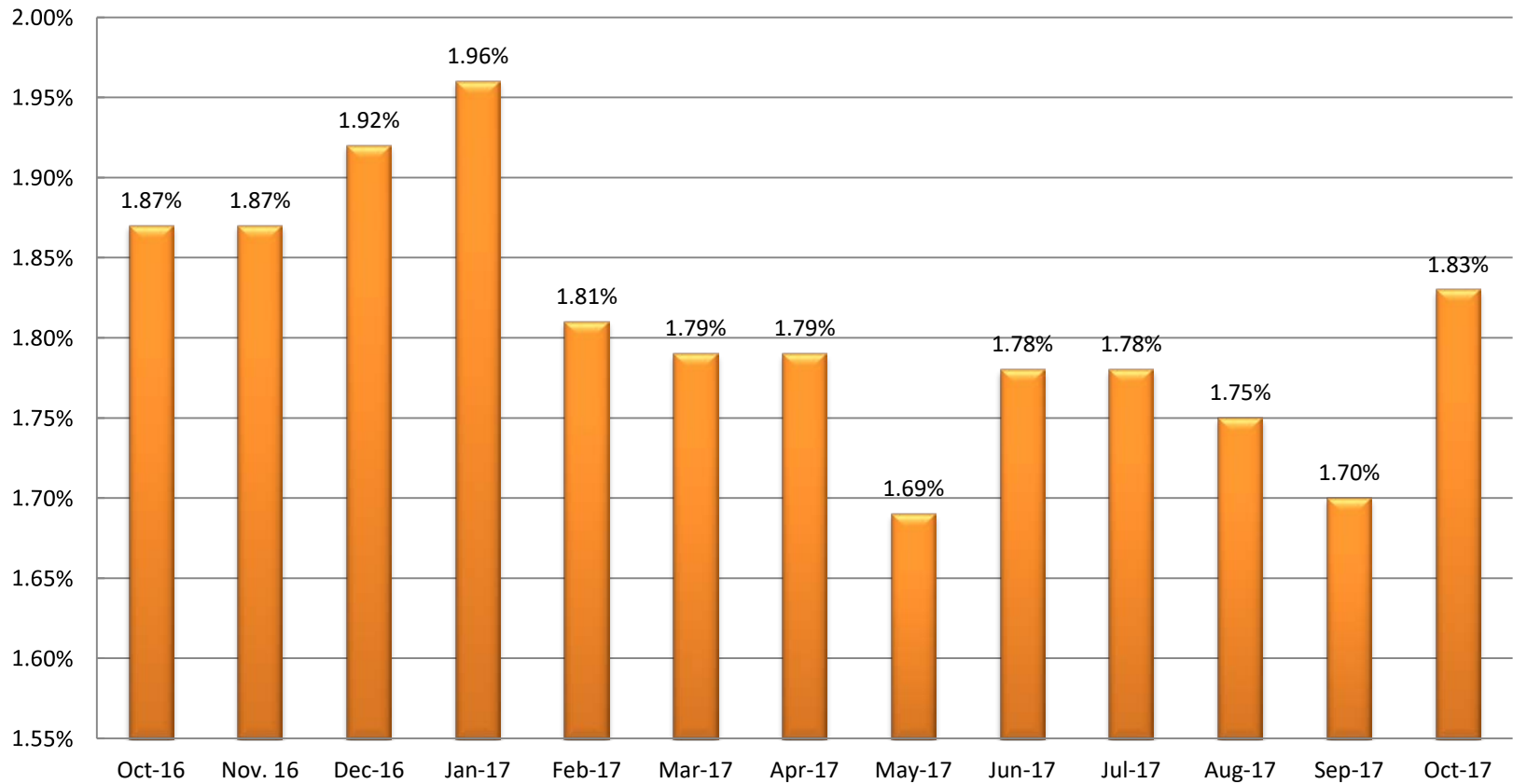


Average # Days to Docket





% Filings Returned to Correction Queue



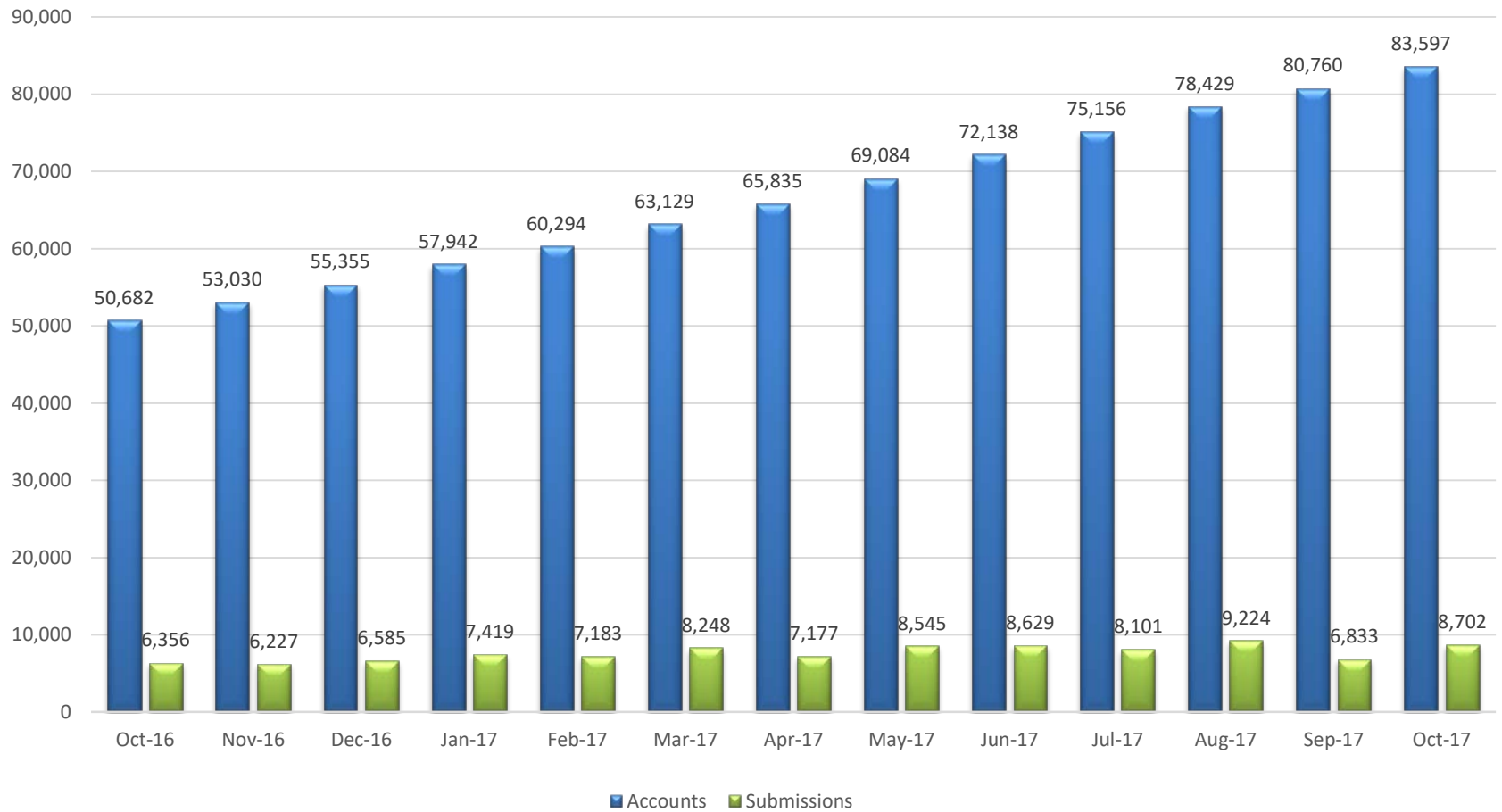

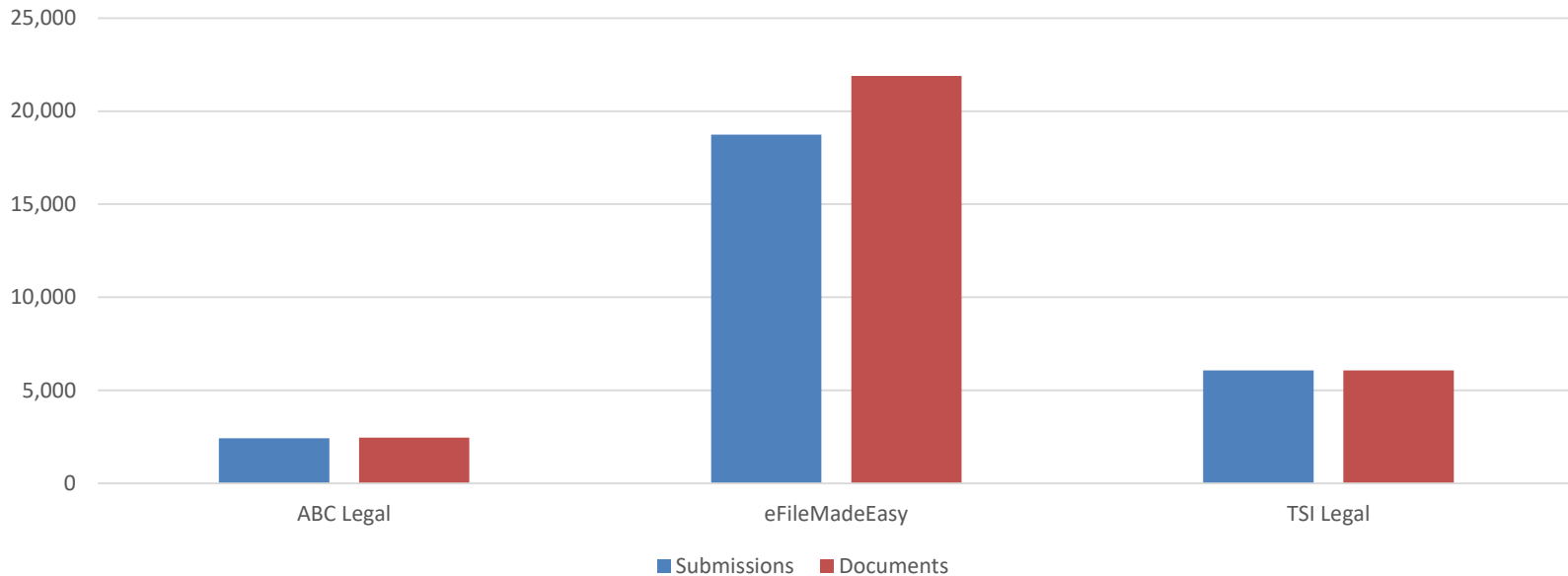


Self-Represented Litigant Accounts and Submissions

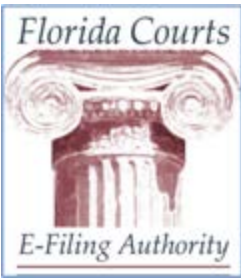




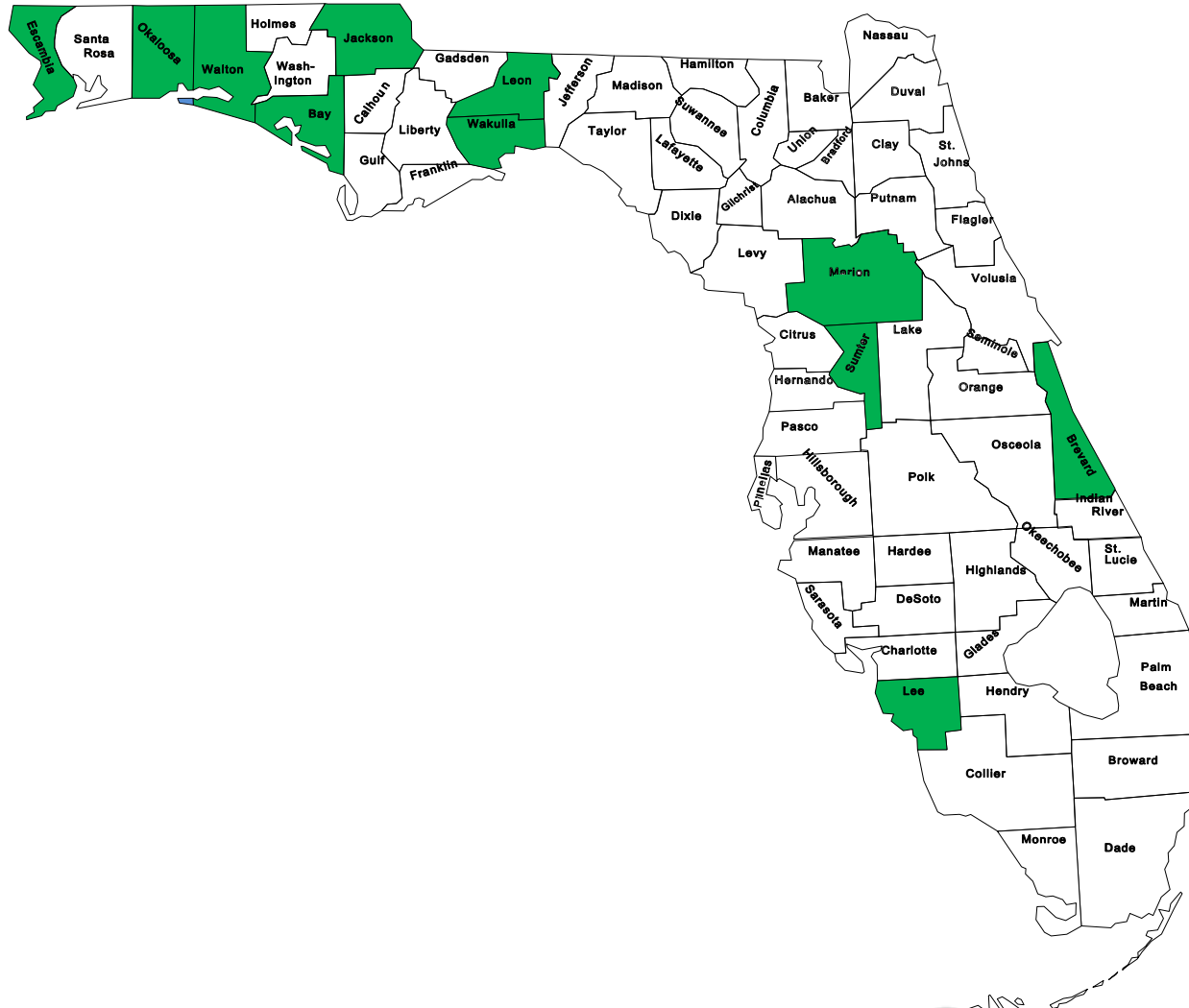
