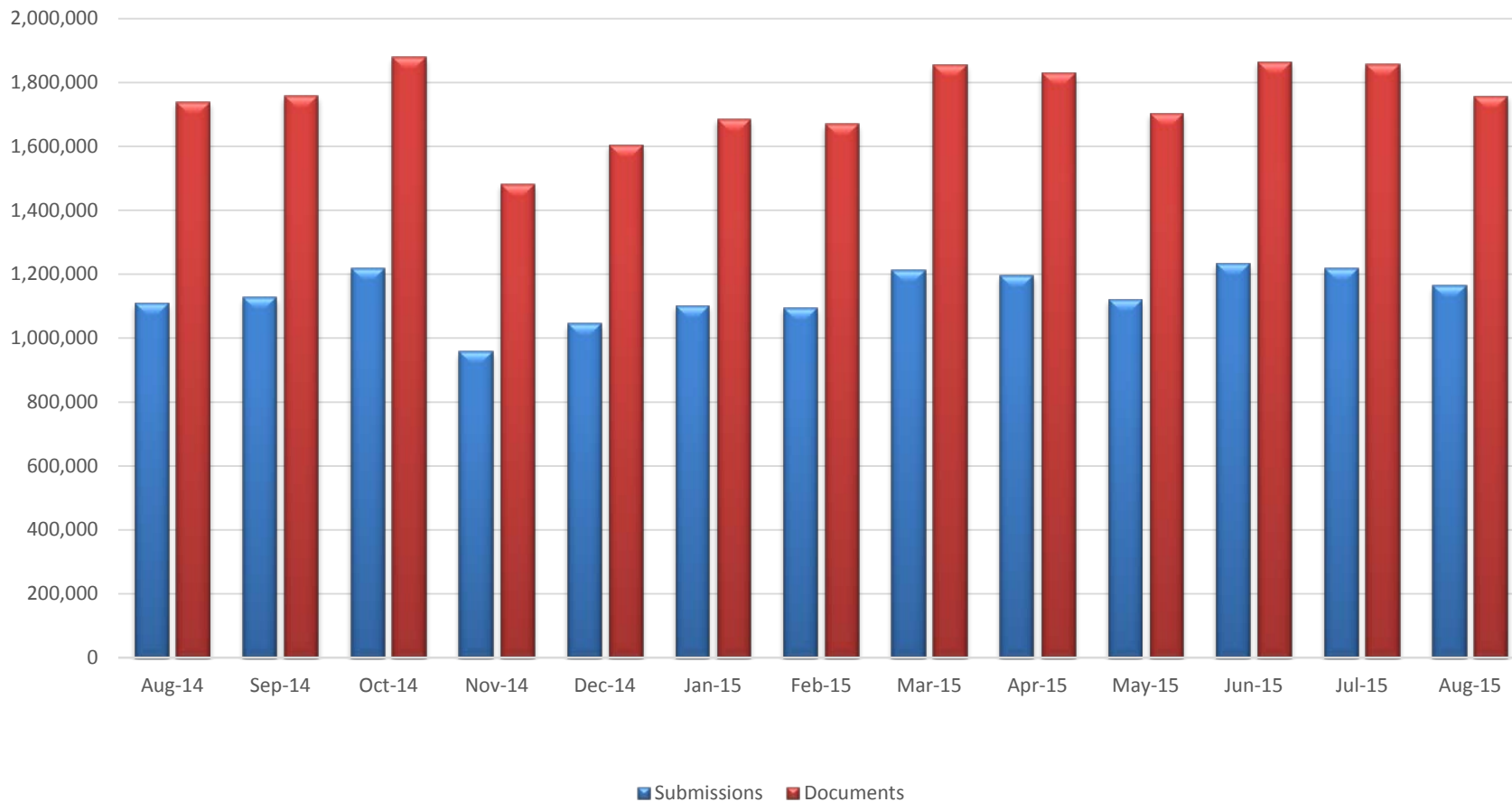

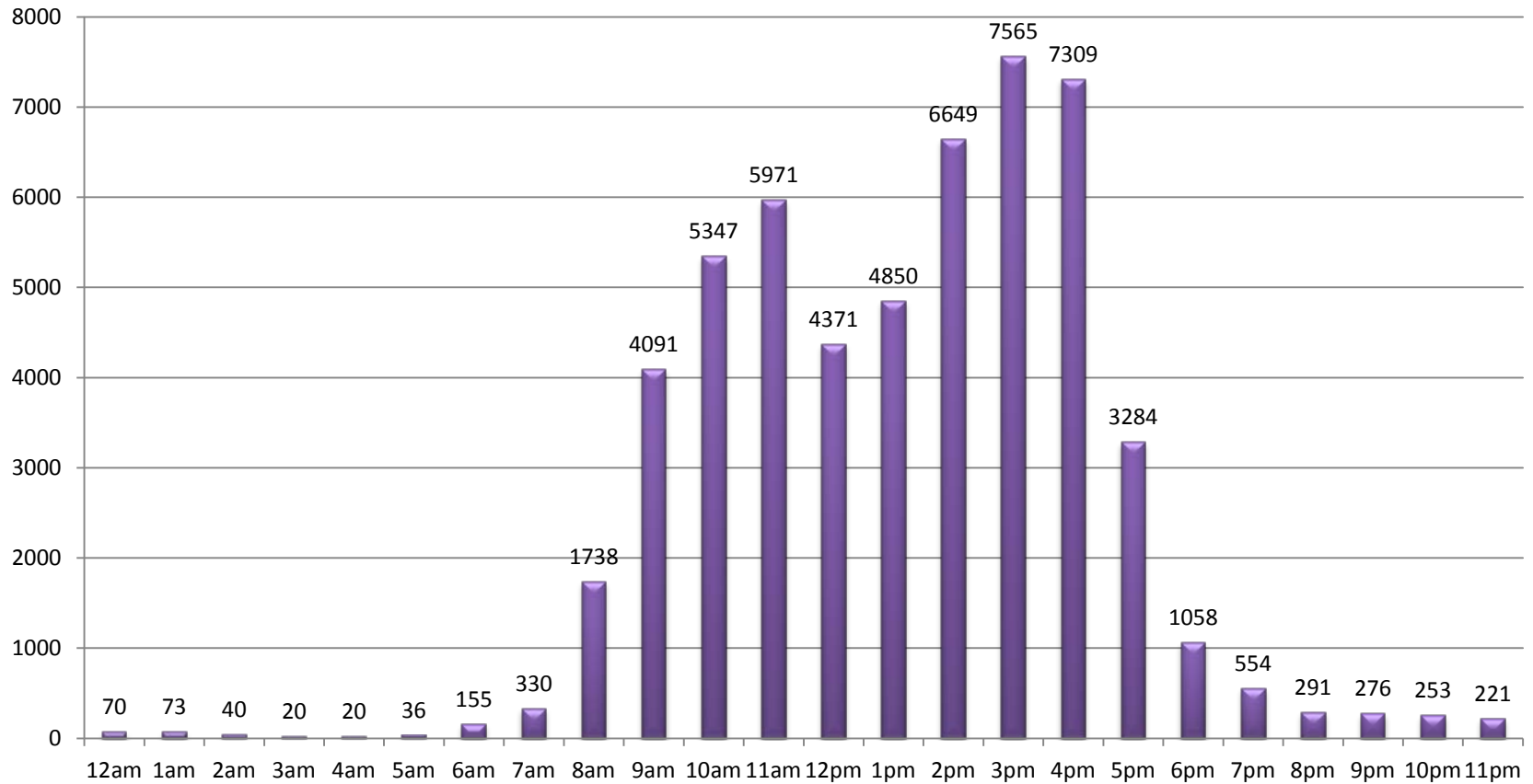


# Monthly E-Filing Submissions for August 2014 through August 2015



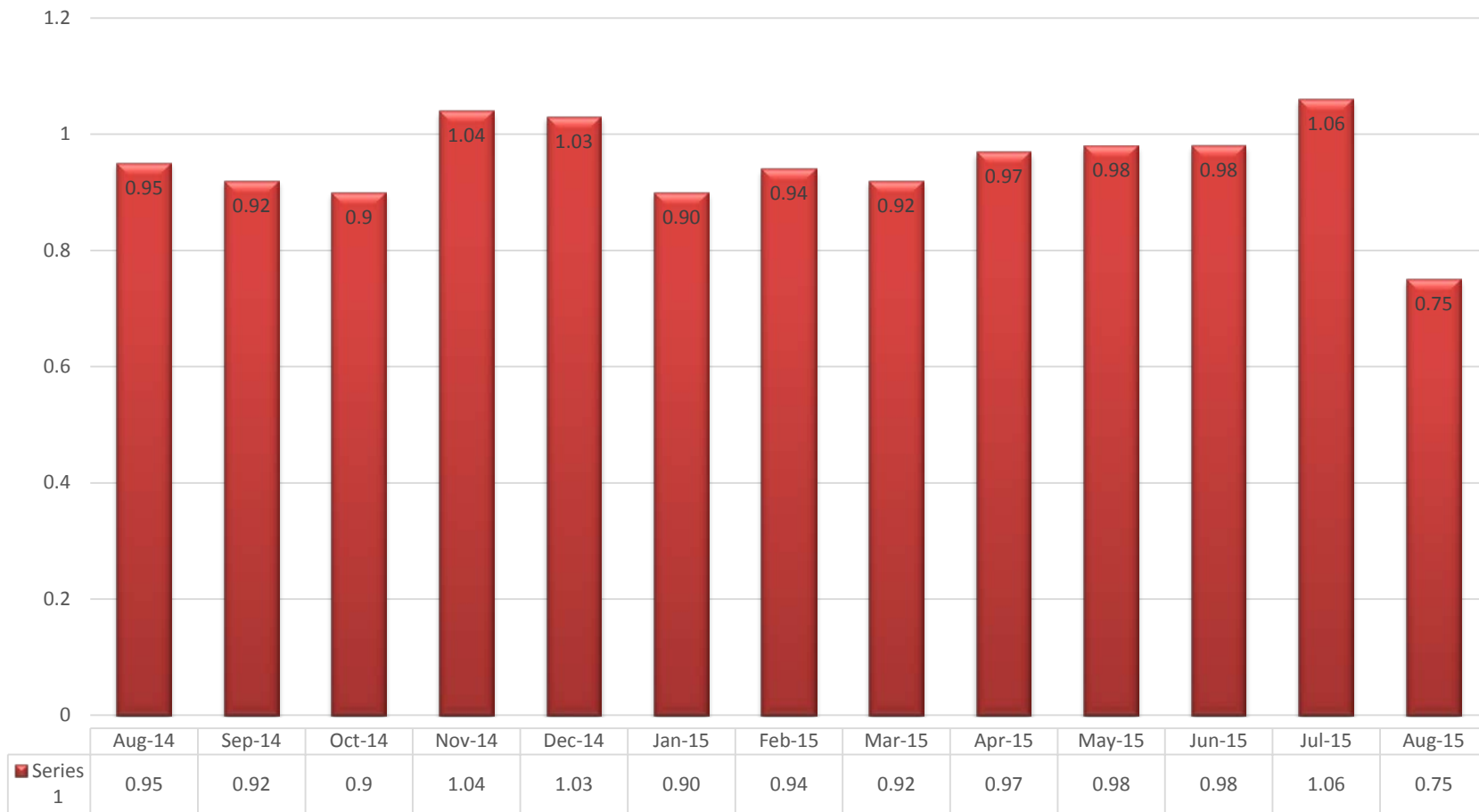


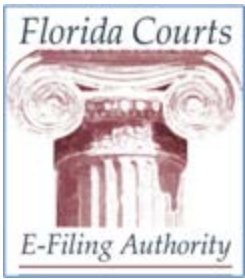
# August Average Hourly Submissions



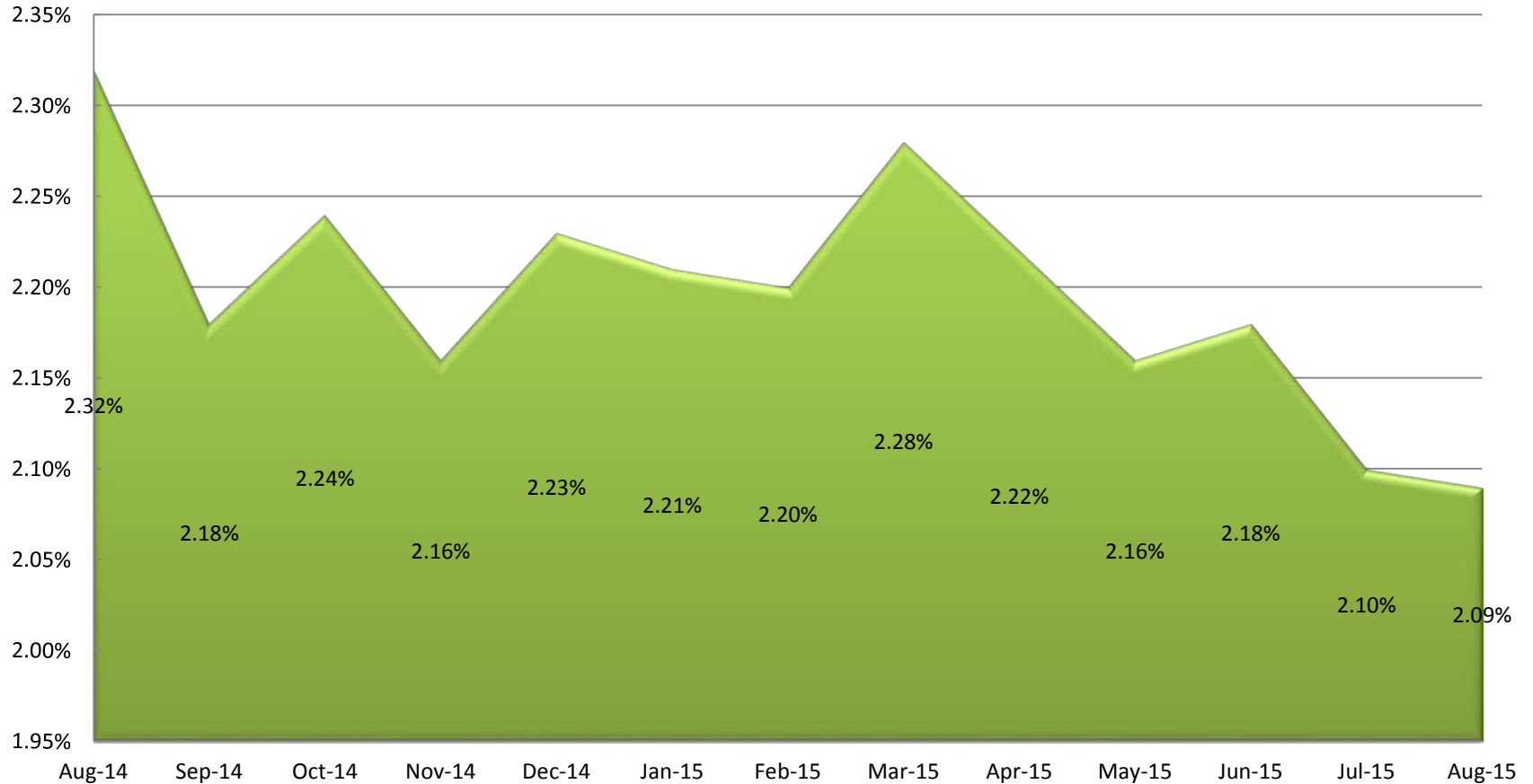


# Average # Days to Docket





# % Filings Returned to Filer for Correction in August



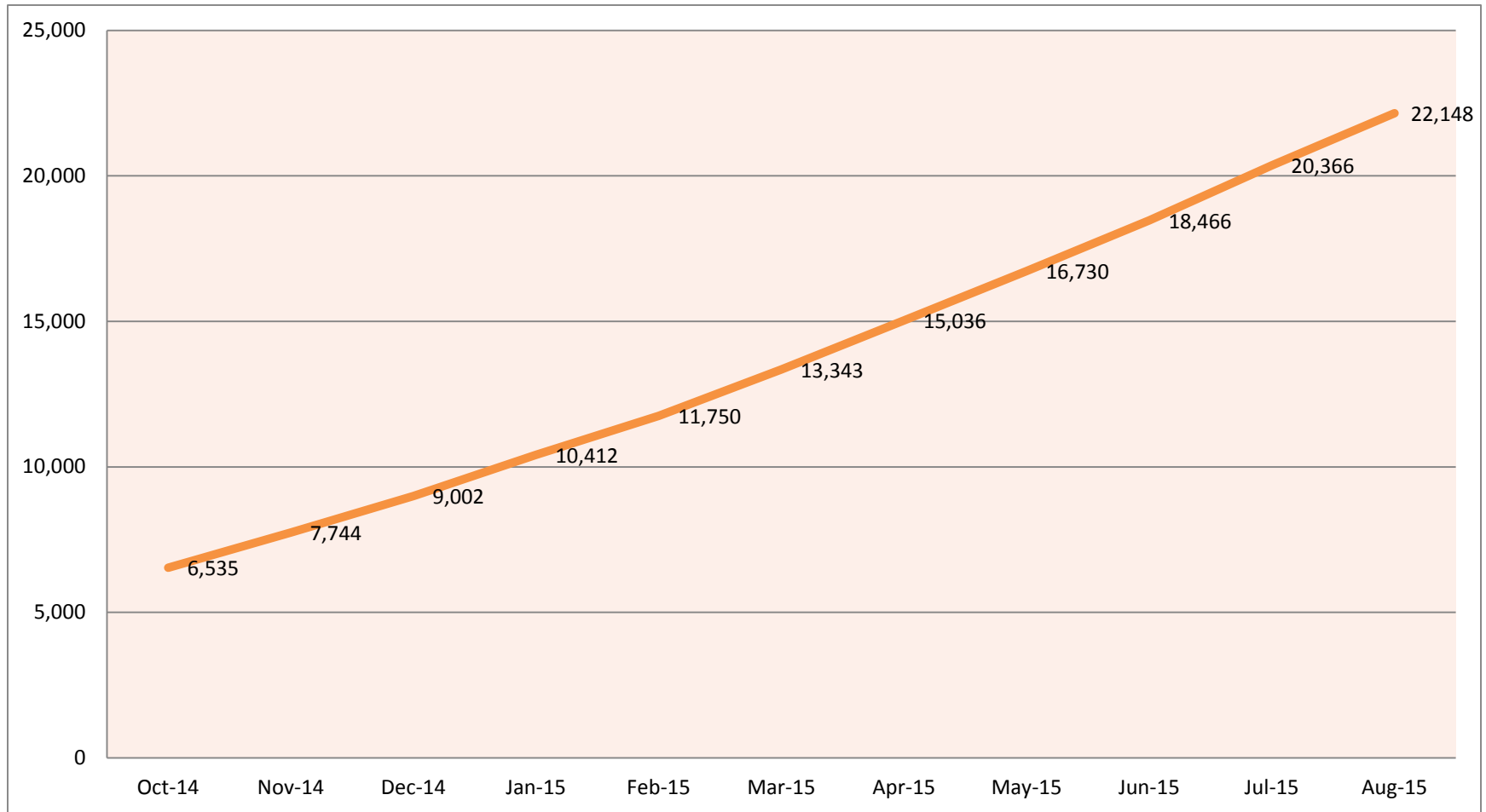

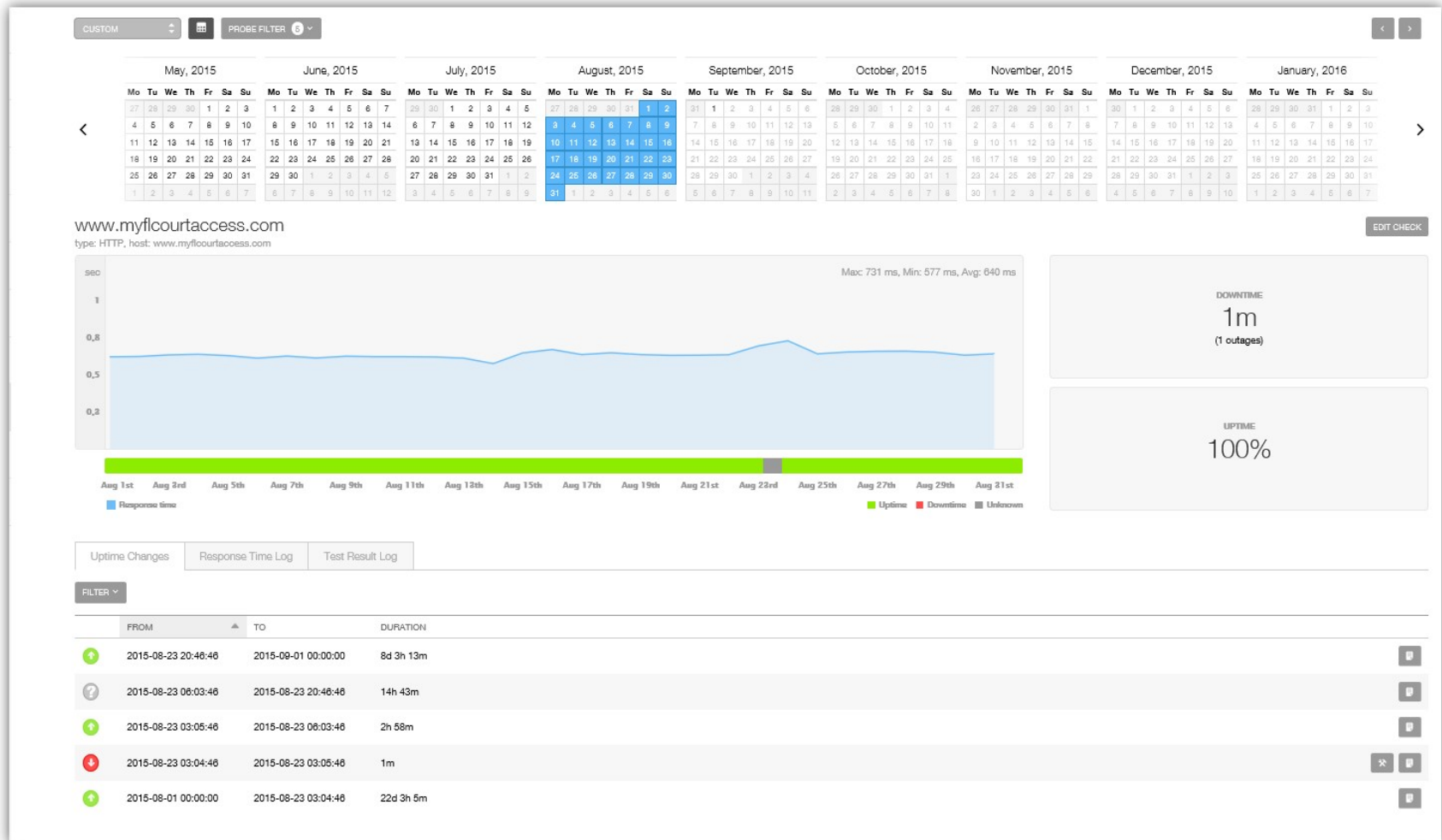
# Self-Represented Litigant Accounts
